
- 2. Recognition & Awards Cover Sheet and submission instructions for each award category.

- 2. Important guidelines to follow when preparing your program/project write ups:
  - ➤ <u>DO NOT</u> use the name of the school, PTA President or Principal in your one-page description of your program(s)/project(s).
  - Limit program description to **ONE** typed page **per** award category
  - The number of programs/projects described in each award category is not limited, as long as the <u>category does not exceed one page</u>.
  - Programs/projects <u>may</u> be included in more than one category.
  - Program (s) description could include:
    - Who was involved in the program/project parents, teachers, students, community, other schools, other PTA/PTSA units, etc.
    - Cost of the program/project
    - o If the program/project met your unit's goals
    - o How the program/project benefitted parents, students, school, community, etc.
  - Submit one Award Category per sheet
    - Original Award write up goes in the Presentation folder with the cover sheet and requested documents
    - Submit 2 additional copies of ONLY the award write ups outside the presentation folder

(You may include a brief written description to accompany submissions, but it is <u>not required</u>. Only <u>one set</u> of material is required to be submitted for this award.)

<u>Communication</u> - This is about showing how you disseminate meaningful information to assist parents in developing the skills they need to raise and protect their children. To promote the welfare of children and youth in home, school community and place of worship consistent with the mission and purpose of PTA (local, state, and national). It is not about how events/programs are advertised but rather, the event/information itself.

Submissions could include, but are not limited to: newsletters (submit <u>ONE</u> copy of 3 different editions), Letters Home, Press Releases, Screen Shots from Edline, Facebook, Twitter, website, etc.

<u>Outstanding Service Award</u> – This is an award for an individual PTA leader who demonstrates the PTA Values. Nomination may be submitted for consideration by completing an Outstanding Service Award Nomination Form and attaching a one-page written narrative describing the nominee's achievements and how they exemplify the PTA Values.

• Submit the Outstanding Service Award Nomination Form (included in this package) and a written narrative in support of the nominee. The narrative is limited to one page, using a type font no smaller than 12. Narrative should provide a description of the nominee's achievements and how they exemplify the PTA Values listed on the Nomination Form.

**Spotlight** - This is about documenting the activities of your local unit. It should be meaningful and document your board members, showcase activities, workshops, and programs conducted by and for your membership, as well as suggestions for new and/or improved programs. Content should include comments from your principal detailing how your activities furthered the mission and purpose of PTA on your campus (Will also serve as a great legacy item to leave behind each year.).

• Submission ideas include, but not limited to: history book/scrapbook, yearbook, video/DVD, audio tape, PowerPoint presentation, visual display (posters, science board). You are only limited by your imagination!

<u>Superman of Palm Beach County</u> - Provide a list of your current male members, showing at least <u>25</u> male members. Indicate on the top of the list your PTA/PTSA name, number of male members your unit had last year (if known) and this year. You may also include programs/incentives your unit used to increase male membership, but it is *not* required.

<u>Volunteer Award</u> - Provide a list of the volunteer hours your unit has completed for this school year up to March 31. The number of volunteer hours should be (at a minimum), double the number of enrolled students in the school. Please include a copy of the volunteer hours (VIPS) form from the school.
